PETITION FOR CHARTER

Whereas we the undersigned are interested, from the vocational standpoint, in the profession of Hospital Accounting:

And whereas we are desirous of associating together:

1. To bring about closer cooperation among hospital accountants in order to promote uniformity and efficiency in hospital accounting.
2. To cooperate with hospitals and their associations in matters pertaining to hospital accounting and statistics.

4. To provide a medium for the interchange of ideas and dissemination of material relative to hospital accounting.
5. To encourage and assist in the holding of meetings and conferences on hospital accounting.

We do hereby formally request that the organization effected by the undersigned be granted a charter as a regular Chapter of the said American Association of Hospital Accountants with all the rights and privileges pertaining thereto, and that this organization will be known as the Mississippi Chapter of the American Association of Hospital Accountants.

In submitting this petition, we, the undersigned, recognize and accept the following obligations:

1. That the Mississippi Chapter shall operate in conformity with the Constitution and By-Laws of the American Association of Hospital Accountants.
2. That all matters of policy such as eligibility for membership, classes, and privileges of membership, dues, etc., shall conform to the principles which have been or may be established by the American Association of Hospital Accountants.

3. That every effort shall be made by the Members of the local Chapter to conduct its activities in accordance with the high standards of the Association so that the best interests of both the Chapter and the American Association may be served.
